NOTIFICATION

In exercise of the powers conferred by clause(I) to (VIII) of sub-section (5) and clause (1) to (9) of sub-section 6 of section (3) of the Essential Commodities Act, 1955 (10 of 1955) read with the notification of the Govt. of India in the Ministry of consumer Affairs, Food & Public Distribution, No. GSR. 630 (E) dated 31/8/2001 with the prior concurrence of the central Government the Governor of Arunachal Pradesh hereby makes the following Order namely: -

ARUNACHAL PRADESH FOOD STUFF (HOARDING AND PROFITEERING) CONTROL ORDER, 2005.

1. <u>SHORT TITLE, EXTEND AND COMMENCEMENT:</u>

- 1. This may be called the Arunachal Pradesh Food Stuff (Hoarding and Profiteering) Control order, 2005;
- 2. It shall extend to the whole of the State of Arunachal Pradesh;
- 3. It shall come into force at once;
- 2. Definition, in this order, unless the context otherwise requires:
 - a) "Food Stuff" means pulses, mustard oils, other edible oils, Iodised Salt, wheat and their by-products and includes items mentioned in Schedule –I to this order and any other classes of commodities which the Governor of Arunachal Pradesh may by order to be Food Stuff for the purpose of this order;
 - b) "Deputy Commissioner" means the Deputy Commissioner within their respective jurisdictions;
 - c) "Person" means any person dealing in food stuff;
- 3. (i) All persons dealing in any of items of the food stuff as defined in clause (a) of subsection 2, shall display the stock position and sale price item wise on a board fixed at prominent place in the establishment/shop within a reasonable distance from sale counter in the form of schedule –II to enable person purchasing or intend to purchase the item(s) for easy reading;
 - (ii) In case the price is not fixed for any item by the manufactures or the Government the sale price for such items shall be fixed by the seller considering the following factors:

- (a) Purchase price
- (b) Transport charges
- (c) Handling charges
- (d) Storage charges of one month
- (e) Interest on investment for one month and
- (f) Profit margin @ 3% on whole sale transaction and 10% for retail sale.

4. <u>Sale stock of food stuff etc:</u>

- (a) No person shall withheld from sale any food stuff ordinarily kept for sale
- (b) No person shall keep more than three months reserved stock of food stuff and the quantity of stock for this purpose shall be determined by the Deputy Commissioner.
- (c) No person shall sell any of the food stuff at rates higher than the fixed by the Government or workout on formula indicate in clause 3(2) above.

5. Power to call for information, search and seizure etc:

The Deputy Commissioner may:

- (a) Issue direction to a person to maintain a prescribed model sale Register, stock Register and R. C. Register separately and produce for inspection such books, accounts and records relating to his business in food stuff.
- (b) Issue direction to any person to furnish information regarding purchase, sale and stock in hand of the food stuff.
- (c) Enter, Search, Seize or authorize in writing any officer of the Government to enter and search any premises, vehicles or places where there is reason to believe that stock of food stuff had been stored in contravention of this order and to seize such stock, any books of accounts and documents which, in his opinion, would be useful for, or relevant to any proceeding under this order.

6. <u>Sanction for prosecution:</u>

No prosecution in respect of an alleged contravention of the provision of this order shall be initiated/launched without the prior sanction of the Director or the Deputy Commissioner in writing.

7. Repeal and Saving:

From the date of commencement of this Order the Arunachal Pradesh Food Stuff (Hoarding and Profiteering) Control Order 1989 shall stand repealed.
