Sir,

In pursuance of Govt. of India's allotment order No. 1-1/2013.BP.III(2) Dated 25/03/2013, I am to furnish herewith the quarterly sub-allocation of Rice (APL)/Wheat(APL) for different allottees in Arunachal Pradesh as per Annexure-I for the month of April/13 to June/13 under TPDS. The quantities allotted under APL will be valid for lifting up to 20th of every allotting month. The payment for cost of food grains allotted will be made to FCI by 15th of every allotting month. As such, the Deputy Commissioner of the concerned district has to allot and lift the food grains every month separately.

You are, therefore requested to issue necessary orders to the Area Managers to release the food grains allotted herein with intimation to all concerned including this Directorate for its drawal by respective allottees every month separately. *The allocation of 3PL rice/wheat and 494 rice are being conveyed separately.*
