NOTIFICATION

In pursuance of the Government of India, Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution letter No. 9-5/2014-B.P II dated 1.9.2017 and even no dated 5.9.2017 and in order to streamline the distribution of foodgrain allocation under Welfare Institution and Hostel Scheme and to ensure genuineness of all the beneficiaries under the Scheme, the Governor of Arunachal Pradesh is pleased to make Guidelines for eligibility criteria for selection and identification of beneficiaries under Government of India's Scheme "Allocation of foodgrains under Welfare Institution and Hostel scheme" as follows with immediate effect:-

1. Guidelines for Welfare Institution:

- i. The institution must be a recognized and established Welfare Institution working for the welfare and development of deprived/ mentally or physically challenged/ underprivileged/ disadvantaged/ destitute/ old age homes/ orphanages and other weaker sections of the society.
- ii. The institution must possess registration or permission or certification from concerned Department of the state Govt. (viz. Social Welfare Department, etc.) for running the Welfare Institution as seen at Annexure-I.
- iii. The institution must not be availing any assistance or subsidy of any similar nature in cash or kind with regards to supply of foodgrain from the Government.
- iv. The numbers of inmates/population should be reviewed yearly by the DF&CSO concerned as deemed necessary from time to time.
- V. All eligible institutions shall be registered under the department of Food & Civil Supplies, Govt of Arunachal Pradesh as beneficiaries under the scheme by the concerned DF&CSO, who shall maintain a separate register in this regard. DF&CSO shall issue a separate Welfare Scheme Group Ration Card to an eligible institution.

vi. Selection process for beneficiaries under the scheme:-

- a. All applicant institution must apply for inclusion under the scheme in the application format prescribed by the F&CS Department. The application must be supported by documents as seen in the Application Format and must be filled up fully. Incomplete application shall be summarily rejected. The application will be received by the DC/DF&CSO concerned of the District.
- b. Verification of the applicant institution and authenticity of the application must be conducted by a board constituted of the concern Administrative Officer, officer of F&CS Department not below the rank of ASIF&CS and an officer of the WCD/SJETA department where the applicant instruction is located. The verification report in writing will be received by the DF&CSO concerned and approval of the Deputy Commissioner shall be sought for the inclusion/selection of the applicant.
- c. In case of any complaints regarding selection of applicants, the matter will be

- settled by the Deputy Commissioner concerned in the district. The decision of the Deputy Commissioner shall be final and binding upon the applicant institutions.
- d. Information regarding the Welfare Institution thus selected must be conveyed to the Director of F&CS in writing by the DF&CSO concerned and a copy of the same shall be given to the applicant institution and concerned Department (i.e. Social Welfare Department, etc as the case may be) and Deputy Commissioner of the District.
- e. Selected list of Welfare Institutions with their full address and nos. of inmates will be posted in the Department's website and at the Notice Board of the concerned DF&CSO's office.
- f. The institution must be certified by the verifying board in vi (b) above that the same is smoothly run in the past 3(three) years with public interest in view.
- g. In the event of the institution having engaged in any unlawful/anti-social activities or malpractices, if the concerned Deputy Commissioner is satisfied with the report of State Police and local authorities that the institution is engaged in unlawful/anti-social activities, then, by issuing an order in this regard the Deputy Commissioner shall make known that the institution shall immediately cease to be a registered under Welfare Institution under F&CS Department and that all benefits from the Scheme to the Institution shall stop forthwith.

2. Guidelines for Hostel:-

- The hostel must be a recognized and established Hostel where 2/3 (two-third) of the inmates/students must belong to ST/SC or OBC category.
- ii. The hostel must possess registration or permission or certification from concerned department of State Govt. (viz. School Education Department, etc.) for running the hostel/institution as seen at Annexure-III.
- iii. Assistance or Subsidy of any similar nature in cash or kind with regards to supply of' foodgrain/food must not be already availed by the hostel/institution.
- iv. The numbers of inmates/students should be reviewed yearly after every year by the DF&CSO concerned as deemed necessary by him/her.
- V. All eligible hostels shall be registered under the department of Food & Civil Supplies, Govt of Arunachal Pradesh as beneficiaries under the Scheme by the concerned DF&CSO, who shall maintain a separate register in this regard. A separate scheme Group Ration Card shall be issued to an eligible hostel.
- vi. Selection process of Beneficiaries under the Scheme -
- All applicant hostels must apply for inclusion under the Scheme by the Application Format prescribed by F&CS Department.
- b. The application must be supported by documents as seen in the Application Format and must be filled up fully. Incomplete application will be summarily rejected.
- c. The application will be received by the DF&CSO concerned of the District.
- d. Verification of the applicant institution and authenticity of the application must be conducted by a board constituted of the concern Administrative Officer, officer of F&CS Department not below the rank of ASIF&CS and an officer of the Education department where the applicant instruction is located. The verification report in writing will be received by the DF&CSO concerned and approval of the Deputy Commissioner shall be sought for the inclusion/selection of the applicant. The

e. In case of any complaints regarding selection of applicants, the matter will be settled by the Deputy Commissioner concerned in the district. The decision of the Deputy Commissioner shall be final and binding upon the applicant hostels.

f. Information regarding the Hostel thus selected must be conveyed to the Director of F&CS in writing by the DF&CSO concerned and a copy of the same shall be given to the applicant institution and concerned Department (i.e. Education Department, etc as the case may be) and Deputy Commissioner of the District.

g. Selected list of Hostels with their full address and nos. of inmates will be posted in the Department's website and at the Notice Board of the concerned DF&CSO's

office.

h. The hostel must be certified by the verifying board in vi (b) above that the same is

smoothly run in the past 3(three) years with public interest in view.

- i. In the event of the hostel having engaged in any unlawful/anti-social activities or malpractices, if the concerned Deputy Commissioner is satisfied with the report of State Police and local authorities that the institution is engaged in unlawful/antisocial activities, then, by issuing an order in this regard the Deputy Commissioner shall make known that the institution shall immediately cease to be a registered under Welfare Institution under F&CS Department and that all benefits from the Scheme to the Institution shall stop forthwith.
- 3. Utilization Certificate in the prescribed format of GFR-12-C (GFR 2017) in respect of foodgrains utilized by the district for the corresponding previous half year (6 months) must be submitted by the district to the Director of Food & Civil Supplies.
- 4. There should be periodical audit of the scheme every half year (6 months) at the district level and the district shall submit this Audit Report for the period it was completed along with the Utilization certificate. The audit shall be done by a team/board consisting of-

i. Authorized representatives of F&AO (AO/AAO etc)

ii. Accountant/Assistant or equivalent representative of DF&CSO

- iii. Representative of Education or WCD/SJETA departments in the district.
- 5. The cost deposit, procurement, drawal and transportation of the foodgrain under the scheme may be entrusted to the existing district PDS land route carriage contractor at the existing rate of Tide Over allocation which shall be passed on to the consumers/beneficiaries of the scheme as per the notification.

6. The rates of Rice under this scheme shall be as per the rates notified in the Arunachal Pradesh Gazette vide No.DFCS-12012/5/2023 dated 15th March, 2024.
